- Gender-responsive programming

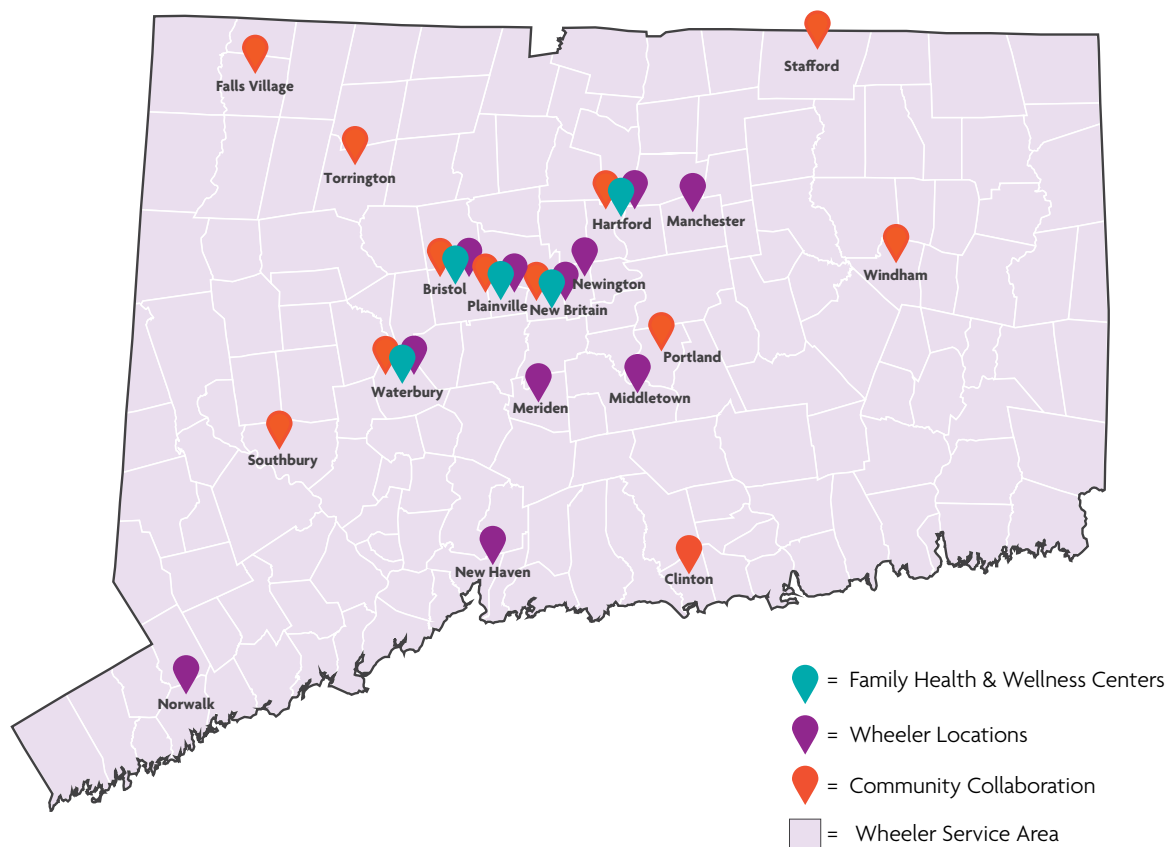
